On April 13, 2023, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) limiting the Respondent’s professional nursing license (#96023-30). Requiring the Respondent to complete four (4) hours of education in “documentation” and four (4) hours in “therapeutic communication with patients” within ninety (90) days and pay \$2,186.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent’s professional nursing license (#96023-30) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credential are removed.
3. This order is effective the date of its signing.
