On April 13, 2023, the Wisconsin Board of Nursing issued a Final Decision and Order ("Order") requiring Respondent to complete three (3) hours of education in "ethics", three (3) hours of education in "boundaries", and one (1) hour of education on the Wisconsin Nurse Practice Act within ninety (90) days and pay \$850.00 in costs of the proceeding within six (6) months.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

1. Respondent's professional nursing license (#319774-31) is hereby returned to full, unrestricted status.
