The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. Cheryl A. Vader, R.N., A.P.N.P. (Respondent), (Year of Birth 1954) is licensed in the state of Wisconsin as a registered nurse, having license number 134890-30, first issued on May 1, 2000 and current through February 29, 2024. Respondent is also certified as an advanced practice nurse prescriber, having certificate number 2686-33, first issued on October 19, 2005, with an expiration date of September 30, 2022.<sup>1</sup> Respondent's most recent address on file with

the Wisconsin Department of Safety and Professional Services (Department) is in Escanaba, Michigan 49829.

2. The Department received notification from the Michigan Board of Nursing that Respondent agreed to a voluntary surrender of her registered nurse and nurse practitioner licenses in lieu of potential discipline.

3. Per the Consent Order in Michigan's Board of Nursing file number 47-21-001612, Respondent self-prescribed non-controlled medications over several years for various and chronic medical conditions.

4. Respondent has not worked or lived in Wisconsin for several years and has retired from the practice of nursing.

5. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

1. The Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 440.19 and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

#### ORDER

1. The attached Stipulation is accepted.

2. This Order is effective on the date of its signing.

3. The SURRENDER of the license and privilege of Respondent (license number 134890-30) to practice nursing in the state of Wisconsin or her privilege to practice in Wisconsin under another state license pursuant to the Nurse Licensure Compact (Compact), as well as Respondent's certification to act as an advanced practice nurse prescriber (certificate number 2686-33) in the state of Wisconsin, as well as any appurtenant rights of renewal for both credentials, are hereby accepted.

4. In the event Respondent petitions the Board of Nursing for reinstatement as a nurse in the future, the Board may enter an order denying such application without further notice or hearing. Whether to grant a license and whether to impose any limitations or restriction on any license granted shall be in the discretion of the Board.

5. In the event Respondent petitions the Board for reinstatement of her license to practice as a registered nurse or advanced practice nurse prescriber in the state of Wisconsin or applies for another credential in the state of Wisconsin, Respondent shall pay the costs of this matter in the amount of \$259.00 before any petition is considered.

6. Any petitions and payments of costs (made payable to Department of Safety and Professional Services), if applicable, required by this Order shall be submitted to:

STIPULATION

Division of Legal Services and Compliance Case No. 23 NUR 021

Cheryl A. Vader, R.N., A.P.N.P. (Respondent) and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.

2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Respondent;
- the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
- the right to testify on Respondent's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.

4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Board of Nursing (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division


of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.

7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.

8. Respondent is further informed that should the Board adopt this Stipulation, the Board's Final Decision and Order will be reported as required by the National Practitioner Databank (NPDB) Guidebook and as otherwise required by any licensure compact or any other state or federal law.

9. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
