On April 13, 2023, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) requiring Respondent to complete five (5) hours of education in “documentation” within ninety (90) days and pay \$635.00 in costs of the proceeding within ninety (90) days.
