On April 13, 2023, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) requiring Respondent to complete six (6) hours of education in “gestational hypertension” and three (3) hours of education on “recordkeeping” and within ninety (90) days and pay \$2,569.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent’s professional nursing license (#129725-30), advanced practice nurse prescriber (#3065-33), and nurse midwife (#148797-32) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credential are removed.
3. This order is effective the date of its signing.
