On April 13, 2023, the Wisconsin Board of Nursing issued a Final Decision and Order ("Order") requiring Respondent to complete six (6) hours of education in "gestational hypertension" and three (3) hours of education on "recordkeeping" and within ninety (90) days and pay \$2,569.00 in costs of the proceeding within ninety (90) days.
