On April 13, 2023, the Wisconsin Real Estate Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent Robin Fazio's real estate broker license, and Respondent Angelo Fazio's real estate salesperson license. Both Respondents were required to complete one (1) remedial education course on the topic of forms pursuant to the terms of the Order.


Respondent Robin Fazio and Respondent Angelo Fazio have submitted proof that they successfully completed the required education, and as a result the following is entered:

ORDER

1. Respondent Robin Fazio's real estate broker license (no. 50225-90) is returned to full, unrestricted status.
2. Respondent Angelo Fazio's real estate salesperson license (no. 52408-94) is returned to full, unrestricted status.
3. All limitations and encumbrances upon both Respondent's credentials are removed.
4. This order is effective the date of its signing.
