On May 3, 2023, the Wisconsin Dentistry Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete two (2) hours of education in "ethics" and two (2) hours of education in "treatment planning" within ninety (90) days and pay \$823.00 in costs of the proceeding within ninety (90) days.
