On May 3, 2023, the Wisconsin Dentistry Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete two (2) hours of education in "responsible prescribing of controlled substances for the treatment of acute dental pain" and three (3) hours of education in the topic of "risk management" within ninety (90) days and pay \$1,129.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent's license to practice dentistry (#1001687-15) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
