On May 3, 2023, the Wisconsin Physical Therapy Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete four (4) hours of education in "ethics and boundaries" and four (4) hours of education in "documentation" within ninety (90) days and pay \$897.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent's license to practice physical therapy (#15120-24) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
