On May 11, 2023, the Wisconsin Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s professional nursing license. Respondent was required to complete two (2) hours of education in medication administration and two (2) hours of education in ethics, pursuant to the terms of the Order. Respondent was also required to pay \$465.00 in costs.

Respondent has submitted proof that she successfully completed the required education and paid all required costs. As a result the following is entered:

ORDER

1. Respondent’s professional nursing license (#226568-30) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credential are removed.
3. This order is effective the date of its signing.
