On May 11, 2023, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) requiring Respondent to complete three (3) hours of education in “ethics and professionalism”, three (3) hours of education on “out-of-state and/or telehealth practice” within ninety (90) days, and pay \$463.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent’s registered nursing license (#142072-30) and advanced practice nurse prescriber license (#9835-33) are hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credentials are removed.
3. This order is effective from the date of its signing.
