On May 17, 2023, the Wisconsin Medical Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete twenty-three and a half (23.50) AMA PRA Category 1 credits in education on the "Intensive Course in Controlled Substance Prescribing Continuing Medical Education" offered by Case Western Reserve University School of Medicine within one hundred eighty (180) days and pay \$1,237.00 in costs of the proceeding within ninety (90) days.
