On June 26, 2023, the Wisconsin Board of Nursing ("Board") issued an Order Granting Limited License ("Order") granting Applicant a limited registered nurse credential (no. 1106868-30) with certain terms and conditions, including participation in a drug monitoring program.

The Board designee has considered Applicant's request for a reduction in the frequency of drug screens. Based upon the information of record, the following is entered:
