On July 12, 2023, the Wisconsin Dentistry Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete ten (10) hours of education on Dental Town's four course program "The Ultimate Guide to Dentistry's Standard of Care", six (6) hours on "Diagnosing and treating periodontal disease", two (2) hours on "Proper coding of dental procedures and diagnoses", and two (2) hours on "communicating with patients" within ninety (90) days and pay \$981.00 in costs of the proceeding within ninety (90) days.
