On July 12, 2023, the Wisconsin Dentistry Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete CE requirements contained in Wis. Admin. Code ch. DE 13, for the biennium ending September 30, 2021 within one hundred twenty (120) days and pay \$857.00 in costs of the proceeding within ninety (90) days.
