On July 13, 2023, the Wisconsin Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s registered nurse and advanced practice nurse prescriber licenses. Respondent was required to complete three (3) hours of education in professional ethics pursuant to the terms of the Order. Respondent was also required to pay costs in the amount of \$938.00.

Respondent has submitted proof that she successfully completed the required education and paid costs in full. As a result the following is entered:

ORDER

1. Respondent’s license to practice as a registered nurse (license number 133131-30), her certificate to practice as an advanced practice nurse prescriber (certificate number 2798-33, and her privilege to practice in Wisconsin pursuant to the Nurse Licensure Compact are returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credentials are removed.
3. This order is effective the date of its signing.
