On July 13, 2023, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) requiring Respondent to complete four (4) hours of education in “patient safety” and four (4) hours of education in “medication documentation and preventing errors”, within ninety (90) days and pay \$837 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent’s professional nursing license (#225856-30) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credential are removed.
3. This order is effective the date of its signing.
