The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

- 1. Respondent Linda S. Beaber, R.N., (Year of Birth 1964) is licensed in the state of Wisconsin as a registered nurse with multi-state practice privileges pursuant to the Nurse Licensure Compact (Compact), having license number 103188-30, first issued on October 27, 1989, and current through February 29, 2024. Respondent's most recent address on file with the Department of Safety and Professional Services (Department) is in Kenosha, Wisconsin 53143.
- 2. At all times relevant to this proceeding, Respondent was employed as a registered nurse at a nursing home in Racine, Wisconsin (Facility).
- 3. On October 24, 2021, a Facility CNA reported that Respondent was "not acting right." She was wandering around the parking lot of the Facility and rummaging through the back

seat of her car in an erratic manner. The Facility's Director of Nursing accompanied Respondent to the Facility lobby where staff witnessed Respondent dozing off, after which she was taken to the hospital for evaluation.

- 4. Following her departure, the Director of Nursing completed a narcotics reconciliation of Respondent's medication cart and discovered the following:
 - a) On October 16, 2021, Resident A's hydrocodone prescription was discontinued. However, Respondent signed out two (2) tablets of hydrocodone for Resident A on both October 18 and 23, 2021, which were unaccounted for.
 - b) On October 19, 2021, Resident B's diazepam prescription was discontinued. However, Respondent signed out three (3) diazepam tablets on October 23, 2021, which were unaccounted for.
 - c) On October 19, 2021, Resident C's diazepam prescription was discontinued. However, Respondent signed out one (1) diazepam tablet on October 23, 2021, which was unaccounted for.
- 5. On October 29, 2021, the Facility terminated Respondent's employment after she refused to speak with Facility management or submit to a urine drug screen.
- 6. On February 22, 2022, Respondent was released from an inpatient behavioral health treatment facility with the following diagnoses: (1) opioid use disorder-severe; (2) sedative, hypnotic, or anxiolytic use disorder-severe; (3) amphetamine-type substance use disorder-severe; (4) bipolar I disorder; and, (5) post-traumatic stress disorder. Her treatment team recommended that Respondent attend Narcotics Anonymous and participate in a partial hospitalization program.
- 7. In March 2022, Respondent completed the partial hospitalization program and in April 2022, she completed an intensive outpatient program. Respondent maintains she has been sober since January 2022.
- 8. On April 11, 2023, Respondent voluntarily entered into the Department's Professional Assistance Procedure (PAP) program for professionals with substance abuse issues.
- 9. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07 and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondent was unable to practice safely by reason of alcohol or other substance use within the meaning of Wis. Admin. Code § N 7.03(6)(f).

- 3. By the conduct described in the Findings of Fact, Respondent dispensed any drug other than in the course of legitimate practice or as otherwise prohibited by law, within the meaning of Wis. Admin. Code § N 7.03(8)(b).
- 4. As a result of the above conduct, Respondent is subject to discipline pursuant to Wis. Stat. § 441.07(1g)(b), (c), and (d), and Wis. Admin. Code. § N 7.03.

ORDER

- 1. The attached Stipulation is accepted.
- 2. Respondent is REPRIMANDED.
- 3. Respondent's license to practice as a registered nurse (license number 103188-30), and privilege to practice in Wisconsin pursuant to the Compact, are LIMITED as follows:

Education

- a. Within ninety (90) days of the date of this Order, Respondent shall at her own expense, successfully complete three (3) hours of education on the topic of dispensing and/or administration of controlled substances offered by a provider preapproved by the Board's monitoring liaison, including taking and passing any exam offered for the courses.
- b. Respondent shall submit proof of successful completion of the education in the form of verification from the institution providing the education to the Department Monitor at the address stated below. None of the education completed pursuant to this requirement may be used to satisfy any continuing education requirements that have been or may be instituted by the Board or Department, and also may not be used in future attempts to upgrade a credential in Wisconsin.
- c. The Board's monitoring liaison may change the number of credit hours and/or education topics in response to a request from Respondent. The monitoring liaison may consider the topic availability and/or hours of education when determining if a change to the ordered education should occur.
- d. This limitation shall be removed from Respondent's license after satisfying the Board or its designee that Respondent has successfully completed all the ordered education.

Compliance with PAP Program

- e. Respondent shall comply with the terms of her PAP contract, dated April 11, 2023.
- f. Any violation of the terms of her PAP contract, dated April 11, 2023, is a violation of this Order.

- g. Respondent may petition the Board for removal of this limitation upon successful competition of all terms of her PAP contract.
- h. In the event Respondent is unsuccessfully discharged from the PAP program, Respondent's license may, in the discretion of the Board or its designee, be immediately suspended. In addition to, or instead of, the suspension, the Board may impose additional limitations or restrictions on Respondent's license to address any concerns regarding the conduct referenced in the Findings of Fact and/or Respondent's unsuccessful discharge from the PAP program.
- 4. Within ninety (90) days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$934.00.
- 5. Any requests, petitions, payments of costs (made payable to Department of Safety and Professional Services), and other information required by this Order shall be submitted to:

- 6. Pursuant to Wis. Stat. § 441.51(5)(b), Respondent's multistate licensure privilege to practice in all Compact states besides Wisconsin is deactivated during the pendency of this Order.
- 7. In the event Respondent violates any term of this Order, Respondent's license (number 103188-30), or Respondent's right to renew her license, may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of the Order. The Board may, in addition and/or in the alternative, refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.
 - 8. This Order is effective on the date of its signing.

STIPULATION

LINDA S. BEABER, R.N., RESPONDENT. ORDER 0008639

Division of Legal Services and Compliance Case No. 21 NUR 700

Respondent Linda S. Beaber, R.N., and the Division of Legal Services and Compliance, Department of Safety and Professional Services, stipulate as follows:

- 1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.
- 2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:
 - the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
 - the right to confront and cross-examine the witnesses against Respondent;
 - the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
 - the right to testify on Respondent's own behalf;
 - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
 - · the right to petition for rehearing; and
 - all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
- 3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation. Respondent is represented by Attorney Kristen N. Nelson.
- 4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Board of Nursing (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.

- 5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.
- 6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.
- 7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.
- 8. Respondent is further informed that should the Board adopt this Stipulation, the Board's Final Decision and Order will be reported as required by the National Practitioner Databank (NPDB) Guidebook and as otherwise required by any licensure compact or any other state or federal law.
- 9. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
