Re: UNLICENSED ELECTRICAL WORK

You are hereby notified that you are subject to a forfeiture of **\$1,500.00** in accordance with Wis. Stat. § 101.88(3) because you engaged in electrical work without possessing the necessary credential in violation of Wis. Stat. § 101.862(2) and held yourself out as an electrical contractor in violation of Wis. Stat. § 101.862(1). This forfeiture must be paid within 30 days of the date of mailing of this Notice or additional enforcement action may be taken against you. In addition, you shall not be able to obtain any credentials with the Department until this forfeiture is paid.

The forfeiture of **\$1,500.00** shall be made out to the "Wisconsin Department of Safety and Professional Services." Include in the memo line "21 UNL 092" and send to the following address:

You are receiving this forfeiture because a Department investigation found by a preponderance of the evidence that you engaged in electrical work and improperly held yourself out as an electrical contractor when you did not possess any electrical credential with the State of Wisconsin. The investigation found that you held yourself out as an electrical contractor by creating an invoice for electrical work to be performed at 440 S. Kane Street, Burlington WI. According to Wis. Stat. § 101.862(1) no person may engage in the business of installing, repairing, or maintaining electrical wiring unless the person is licensed as an electrical contractor by the department.

Second, the investigation found that you performed electrical work on two occasions at 440 S. Kane St. Wis. Stat. § 101.862(2) states that no person may install, repair, or maintain electrical wiring unless the person is licensed as an electrician by the department or unless the person is enrolled as a registered electrician by the department. None of the electrical work done was exempted under Wis. Stat. § 101.862(4).

The Department finds one violation of Wis. Stat. § 101.862(1) and two violations of Wis. Stat. § 101.862(2). According to Wis. Stat. § 101.88(3) the Department may enter a forfeiture not less than \$25 nor more than \$500 for each violation. Each day of violation constitutes a separate offense. Therefore, a forfeiture of \$1,500 is appropriate.

The Department afforded you an opportunity to respond. It sent a letter to your address on record with the Wisconsin Circuit Court as of October 18, 2022. No response was received.

You have the right to request a hearing on this matter by sending a request for hearing to the Department of Safety and Professional Services, Chief Legal Counsel, P.O. Box 7190, Madison, Wisconsin 53707-7190, which must be received by the Department no later than 30 days from the date of mailing of this Notice. Any review will be held in accordance with the requirements set forth in Wis. Stat. § 101.02(6). Such request for review shall set out specifically and in full detail every reason why this order is unreasonable, and every issue to be considered by the Department in the review.
