You are hereby notified that you are subject to a forfeiture of **\$1,000.00** in accordance with Wis. Admin. Code § SPS 305.125(1)(b) for performing plumbing work without possessing a plumbing license in violation of Wis. Stat. § 145.06(1)(a). This forfeiture must be paid within 30 days of the date of mailing of this Notice, or a 12% interest penalty will be assessed and/or enforcement action may be taken against you. Further, you shall not be allowed to obtain a credential or renew your credentials from the Department of Safety and Professional Services until this forfeiture is paid.

The forfeiture of **\$1,000.00** shall be made out to the "Department of Safety and Professional Services." Include in the memo line "21 UNL 102" and send to the following address:

You have the right to request a review of the assessment of forfeiture by sending a request addressed to Division Administrator, Division of Industry Services, P.O. Box 7302, Madison, WI 53707-7302. Any review of the assessment of forfeiture will be held in accordance with the requirements set forth in Wis. Admin. Code § SPS 305.125. Such request for review shall set out specifically and in full detail every reason why this order is unreasonable, and every issue to be considered by the Department in the review.

You are receiving this forfeiture because a department investigation found that you performed plumbing at 533 Trillium Lane, Hudson, Wisconsin. It was determined that you installed a water heater. The installation of a water heater is considered plumbing according to Wisconsin statute and code.

The Department attempted to contact you. It sent a letter to your address of record on May 5, 2022, and on October 18, 2022. No response was received. The Department attempted to call at (715) 760-2307, which was the number the Department had on file for you. The voice message identified the company as The Drain Reliever. The Department left a message explaining that a complaint had been filed against you and requesting a response. No response was received. The Department attempted to email you at info@drainreliever.com. The email was undeliverable.

Based on the evidence presented to the Department, there is a preponderance of evidence that you installed plumbing without a proper license. For this reason, a forfeiture of \$1,000.00 is assessed in accordance with Wis. Admin. Code § SPS 305.125.
