On August 17, 2023, the Wisconsin Nursing Home Administrator Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete eight (8) hours of education on the topic of "regulatory requirements for nursing homes" and four (4) hours of education in "nursing facility risk assessments" within ninety (90) days and pay \$1,008.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent's license to practice as a nursing home administrator (#3737-65) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
