Re: UNLICENSED ELECTRICAL WORK

You are hereby notified that you are subject to a forfeiture of \$5,000.00 in accordance with Wis. Stat. § 101.88(3) because you engaged in electrical work without possessing the necessary credential in violation of Wis. Stat. § 101.862(2) and because you engaged in the business of installing, repairing, or maintaining electrical wiring without being licensed as an electrical contractor by the department in violation of Wis. Stat. § 101.862(1). This forfeiture must be paid within 30 days of the date of mailing of this Notice. In addition, you shall not be able to obtain an electrical credential from the Department of Safety and Professional Services until this forfeiture is paid as allowed by Wis. Stat. § 440.21(2).

The forfeiture of \$5,000.00 shall be made out to the "Department of Safety and Professional Services." Include in the memo line "21 COM 134" and send to the following address:

You are receiving this forfeiture because a Department investigation found you performed electrical work at N2276 Frankie Road Mauston, Wisconsin 53948 without possessing any electrical license. A license is required in the State of Wisconsin to perform most electrical work including the work you and your company performed. An investigation by the Department found a preponderance of evidence that you engaged in electrical work. This is a violation of Wis. Stat. § 101.862(2).

Second, the Department found that you and your company held your business out as a business engaged in electrical work without possessing an electrical contractor credential. Every day where you hold yourself out as a business engaging in installing, repairing, or maintaining electrical wiring is considered a violation a Wis. Stat. § 101.862(1). The Department finds that you were engaging in electrical business when you provided the invoice to the property owner of N2276 Frankie Road, when you and your company installed the solar panels at the site, and when you fraudulently signed the Oakdale Electric Cooperative Wiring Affidavit representing that you were an electrical contractor and improperly putting down your dwelling contractor qualifier credential number.

The Department also finds that your website, (https://independent-solar.com/), offering solar panels to the public is a violation of Wis. Stat. § 101.862(1). The Department reviewed a video on your website where you indicate that you are a "full-service solar installer." Further, the video states that "Our Independent Solar Technicians include all permits & inspections..." The Department found that the website listed eight projects in the "portfolio" section showcasing electrical work. Last, the Department performed an internet search and found 42 separate google reviews concerning the work performed which are also linked to your website.

In response to this investigation you stated you denied installing solar panels and that you worked with licensed contractors for the installation. The Department's investigation found that on N2276 Frankie Road you performed the installation and that a licensed electrician came to inspect the site to sign off on the paperwork. Further, the google reviews make clear that you performed the services. A review from Patrick Mcguire states "Jay did the whole job without getting any permits, despite saying that he did... He missed his scheduled appointment 2 times before finally showing up. I had to ask him multiple times where the remaining 2 panels were before he finally told me that he has put them in his truck and was going to take them. When his crew left, they took much of the remaining usable equipment (rails, spare wire, etc.) but left trash all over my garage (a large wood pallet, piles of plastic wrapping, etc.)"

According to Wis. Stat. § 101.88(3) any person who violates subchapter IV of Chapter 101 or any rule promulgated under subchapter IV shall forfeit to the state not less than \$25 nor more than \$500 for each violation and each day of violation constitutes a separate offense. Minimally, the Department finds one (1) violation of Wis. Stat. § 101.862(2) and ten (10) violations of Wis. Stat. 101.862(1). The Department finds that §101.862(1) is being violated each day after the signing of this Order until an electrical contractor credential is obtained and/or the website continues to omit information that alerts the public that Independent Solar is <u>not</u> an electrical contractor and does not have licensed electricians on staff.

You have the right to request a hearing on this matter by sending a request for hearing to the Department of Safety and Professional Services, Chief Legal Counsel, P.O. Box 7190, Madison, Wisconsin 53707-7190, which must be received by the Department no later than 30 days from the date of mailing of this Notice. Any review will be held in accordance with the requirements set forth in Wis. Stat. § 101.02(6). Such request for review shall set out specifically and in full detail every reason why this order is unreasonable, and every issue to be considered by the Department in the review.

The Department is authorized to enter forfeitures up to \$500 for each violation of Wisconsin electrical statute or code. For engaging in electrical work without the proper credential and for engaging in electrical business without possessing an electrical contractor credential the forfeiture of \$5,000.00 is assessed in accordance with Wis. Stat. § 101.88(3).
