The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

- 1. Destiny Green, (Applicant) has filed an application for a registered nurse license (application #IA-0000026619).
- 2. Applicant's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is located in Milwaukee, Wisconsin.
- 3. On or about October 25, 2020, police responded to a report of a fourteen (14) year old, S.S., with a gunshot wound to her abdomen. S.S. reported a fight occurred between her brother and the family of her brother's girlfriend, Applicant. After the fight ended, S.S.'s mother used pepper spray to stop Applicant's family members from entering the house. Following the use of pepper spray, S.S. was shot in the abdomen. S.S.'s mother observed Applicant fire the gun.
- 4. On or about May 17, 2021, Applicant was convicted of injury by negligent handling of dangerous weapon in violation of Wis. Stat. § 940.24(1) for the conduct which occurred on or about October 25, 2020.

- 5. Based on the conduct engaged in by the Applicant and the subsequent conviction, the Board determined that limitations on Applicant's license are the least restrictive alternative available to the Board to adequately protect the public health and safety.
- 6. In resolution of this matter, Applicant consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Board of Nursing has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07 and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. The Board may deny a license pursuant to Wis. Stat. § 441.07(1g) for committing one or more violations of this subchapter or any rule adopted by the Board under the authority of the subchapter.
- 3. By the conduct described in the Findings of Fact, the Board may deny or limit a license if Applicant has violated any law substantially related to the practice of nursing or been convicted of any crime substantially related to the practice of nursing pursuant to Wis. Admin. Code § N 7.03(2).
- 4. As a result of the above conduct, Applicant is subject to limitations on her license pursuant to Wis. Stat. § 441.07(1g)(b) and Wis. Admin. Code § N 7.03(2). The Board has determined that these limitations are the least restrictive options available to the Board to protect the health and safety of the public.

<u>ORDER</u>

- 1. The attached Stipulation is accepted.
- 2. Limitations upon Applicant's license are necessary to ensure that applicant is fit and competent to practice as a registered nurse. Applicant is granted registered nurse license subject to the following limitations, terms, and conditions.
- 3. The registered nurse license issued to Applicant to practice nursing in the state of Wisconsin is LIMITED as follows:
 - a. Applicant shall practice only under the general supervision of a registered nurse approved by the Board or its designee, who has received a copy of this Order.
 - b. Beginning thirty (30) days from the date of this Order, Applicant shall arrange for quarterly written reports to be submitted to the Department Monitor from her supervisor at each setting in which Applicant practiced nursing in the previous quarter. These reports shall be submitted as directed by the Department Monitor, and shall assess Applicant's work performance, and shall include the number of hours of active nursing practice worked during that quarter. If a report indicates poor performance, the Board may

- institute appropriate corrective limitations, or may suspend the Applicant's license, in its discretion.
- Applicant shall report any arrests to the Department monitor within 48 hours.
- 4. Any costs incurred as a result of this Order shall be the responsibility of the Applicant.
- 5. Applicant may petition the Board on an annual basis for modification of the terms of this Order, however no such petition for modification shall occur earlier than one (1) year from the date of the Order. Denial of a petition in whole or in part shall not be considered a denial of a license within the meaning of Wis. Stat. § 227.01(3)(a), and Applicant shall not have a right to any further hearings or proceedings on the denial.
- 6. Applicant may petition the Board for termination of this Order any time after two (2) years from the date of this Order. The Board may grant a petition for full licensure upon a showing by Applicant of continuous, successful compliance for a period of at least two (2) years with the terms of this Order.
- 7. Any requests, petitions, reports and other information required by this Order shall be submitted to:

- 8. In the event Applicant violates any term of this Order, Applicant's license to practice as a registered nurse in the state of Wisconsin, or Applicant's right to renew her license, may, at the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order. The Board may, in addition and/or in the alternative, refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.
 - 9. This Order is effective on the date of its signing.

It is stipulated between Applicant and the Wisconsin Board of Nursing (Board) as follows:

- 1. Applicant has filed an application for a registered nurse license.
- 2. Information received by the Board reflects a basis for denial of the license.
- 3. Based upon the information of record herein, the Board agrees to issue, and Applicant agrees to accept, an Order granting a registered nurse license, subject to the terms and conditions set forth in the attached Order adopting the Stipulation.
- 4. Applicant understands that by signing this Stipulation, Applicant voluntarily and knowingly waives the following rights:
 - the right to request a hearing related to the denial of the application;
 - the right to confront and cross-examine the witnesses against Applicant;
 - the right to call witnesses on Applicant's behalf and to compel their attendance by subpoena;
 - the right to testify on Applicant's own behalf;
 - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
 - the right to petition for rehearing; and
 - all other applicable rights afforded to Applicant under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
- 5. Applicant is aware of Applicant's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.
- 6. Applicant agrees to the adoption of the attached Order Granting Limited License by the Board. The parties to the Stipulation consent to the entry of the attached Order Granting Limited License without further notice, appearance, or consent of the parties.

- 7. Applicant waives all rights to any appeal of the Board's Order, as adopted in the form as attached.
- Applicant is informed that the Order Granting Limited License is a public record and will be published in accordance with standard procedure.
