On September 14, 2023, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) requiring Respondent to complete two (2) hours of education in “ethics in nursing”, two (2) hours of education in “mental health nursing”, and two (2) hours of education in “anger management”, all within ninety (90) days. Additionally, Respondent was required to pay \$299.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent’s professional nursing license (#241288-30) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credential are removed.
3. This order is effective the date of its signing.
