MELIHA SAATCI (Applicant), applied to renew a Board of Nursing (Board) credential after five (5) years, pursuant to Wis. Stat. § 440.08(3)(b) and Wis. Admin. Code §§ SPS 4.10 and N 2.40(3)(d)2. Applicant voluntarily and knowingly agrees to the issuance of a LIMITED LICENSE for the SOLE PURPOSE of completing a Board-approved nurse refresher course (Refresher Course).

NOW, THEREFORE, IT IS ORDERED that Applicant is GRANTED a LIMITED LICENSE for the SOLE PURPOSE of completion of a Refresher Course.

IT IS FURTHER ORDERED that pursuant to the Enhanced Nurse Licensure Compact, this LIMITED LICENSE for the SOLE PURPOSE of enabling the Applicant to complete the Refresher Course is limited to Wisconsin during the duration of this limitation.

IT IS FURTHER ORDERED that the LIMITED LICENSE shall be valid for a period of one (1) year from the date of this Order. If the Refresher Course is not completed within one (1) year from the date of this Order, the LIMITED LICENSE will expire, and the Applicant will need to reapply for a LIMITED LICENSE to complete the Refresher Course.

IT IS FURTHER ORDERED that upon submission of evidence satisfactory to the Board of successful completion of the Refresher Course, the Applicant will receive full licensure once all other requirements are met.
