The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. Respondent Dawn M. Stogenson, R.N., (Year of Birth 1972) is licensed in the state of Wisconsin as a registered nurse, having license number 174322-30, first issued on July 27, 2010. This license expired as of March 1, 2020, and has not been renewed. Pursuant to Wis. Stat. § 440.08(3), Respondent retains the right to apply to renew her license upon payment of a fee until February 28, 2025. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is in Englewood, Florida 34224.

2. Respondent is also currently licensed in the state of Florida as a registered nurse, having single state license number RN9518614. Respondent was first licensed in Florida on August 16, 2019, and current through April 30, 2025.

3. At all times relevant to this proceeding, Respondent worked as a registered nurse at a hospital located in Sarasota, Florida (Hospital).

4. On April 15, 2022, Respondent diverted Trazodone for approximately four months in 2022 while working at the Hospital.

5. On July 6, 2022, Respondent enrolled in the Florida Board of Nursing Intervention Project for Nurses (IPN), an alternative to discipline program in Florida. Pursuant to the IPN, Respondent is required to submit to toxicology testing, attend support groups and meetings, complete continuing education, comply with self-reporting and satisfactory work performance requirements, and complete individual therapy.

6. As of June 9, 2023, Respondent's IPN Case Manager reported that Respondent remains actively engaged and compliant with the IPN contract and requirements.

7. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07 and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. By the conduct described in the Findings of Fact, Respondent is unable to practice safely by reason of alcohol or other substance use within the meaning of Wis. Admin. Code § N 7.03(6)(f).

3. By the conduct described in the Findings of Fact, Respondent obtained, possessed, or attempted to obtain or possess, a drug without lawful authority within the meaning of Wis. Admin. Code § N 7.03(8)(e).

4. As a result of the above conduct, Respondent is subject to discipline pursuant to Wis. Stat. § 441.07(1g)(b), (c) and (d), and Wis. Admin. Code § N 7.03.

ORDER

1. The attached Stipulation is accepted.

2. Respondent is REPRIMANDED.

3. Respondent's license to practice as a registered nurse in Wisconsin (license number 174322-30), and her right to renew that license, is LIMITED as follows:

a. Respondent is to maintain full and complete compliance with all terms, limitations, and conditions of her contract with the Florida IPN.

- b. Respondent shall provide the Board with a copy of any document issued by the Florida IPN or the Florida Board of Nursing which alters the conditions of Respondent's continued practice of nursing in the state of Florida, including any document advising successful completion of the IPN program or reinstatement of full licensure, within fifteen (15) days of issuance of document.
- c. In the event Respondent intends to practice as a registered nurse in Wisconsin during the pendency of this Order, Respondent shall provide the Board with notice in writing at least thirty (30) days prior to the commencement of practice in Wisconsin. That notice shall include identity of the employer, work location(s) including addresses and phone numbers, and the type of practice. The Board may require additional limitations be imposed on Respondent's Wisconsin license based on any limitations or conditions imposed by the Florida Board of Nursing, Respondent's compliance with the Florida IPN, and anticipated scope of practice in Wisconsin.
- d. A determination by the Florida IPN or the Florida Board of Nursing that Respondent has violated any term, limitation, and/or condition of the Florida IPN contract is a violation of this Order.
- e. Upon Respondent providing proof sufficient to the Board, or its designee, that she has successfully complied with all terms and conditions of the Florida IPN contract and her Florida license has been restored to full, unrestricted status, the Board or its designee shall remove the limitation(s) imposed by this Order on Respondent's Wisconsin license.

3. Within ninety (90) days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$856.00.

4. Any requests, petitions, payments of costs (made payable to Department of Safety and Professional Services), and other information required by this Order shall be submitted to:

5. In the event Respondent violates any term of this Order, Respondent's license (number 174322-30), or Respondent's right to renew her license, may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has

complied with the terms of the Order. The Board may, in addition and/or in the alternative refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.

6. This Order is effective on the date of its signing.

STIPULATION

ORDER 008806

Division of Legal Services and Compliance Case No. 22 NUR 288

Respondent Dawn M. Stogenson, R.N., and the Division of Legal Services and Compliance, Department of Safety and Professional Services, stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.

2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Respondent;
- the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
- the right to testify on Respondent's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.

4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Board of Nursing (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division


of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.

7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.

8. Respondent is further informed that should the Board adopt this Stipulation, the Board's Final Decision and Order will be reported as required by the National Practitioner Databank (NPDB) Guidebook and as otherwise required by any licensure compact or any other state or federal law.

9. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
