On October 12, 2023, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) requiring Respondent to complete 2.1 hours of education in “Nurse Practice Act - Wisconsin”, and three (3) hours of education in the topic of ethics, within ninety (90) days. Respondent was also required to pay \$1,011.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent’s registered nurse license (#1107876-30) and certificate to practice as an advanced practice nurse prescriber (#10175-33) are hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credentials are removed.
3. This order is effective the date of its signing.
