The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. Lisa O'Farrell, R.N. (Respondent), (Year of Birth 1974) is licensed in the state of Wisconsin as a registered nurse, having license number 235225-30, first issued on June 1, 2017, and current through February 29, 2024. This license is suspended as of June 13, 2023. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is in Butler, Wisconsin 53007.

2. At all times relevant to this proceeding, Respondent worked as a registered nurse at a hospital located in Milwaukee, Wisconsin (Facility).

Prior Board Action

3. On September 8, 2022, the Board issued a Final Decision and Order (No. 0008155) which suspended Respondent's license. The suspension was stayed with the condition that Respondent enter into and continue drug and alcohol treatment, attend group therapy meetings for alcohol addiction, abstains from all personal use of alcohol and controlled substances, and enroll and participate in an alcohol and drug monitoring program.

4. On December 15, 2022, the Board issued an order removing the stay of the suspension for non-compliance with Order No. 0008155.

5. On January 17, 2023, the Board issued an order reinstating the stay of suspension provided for in Order No. 0008155. The stay was continuous, contingent upon Respondent's compliance with the terms of Order No. 0008155.

6. On June 13, 2023, the Board issued an order removing the stay of suspension for non-compliance with Order No. 0008155. The suspension remains ongoing.

#### Current Case

7. On July 12, 2023, the Department was notified by Division of Legal Services and Compliance Monitoring staff that Respondent was working as a nurse while her license was suspended. The Facility reported that it would be terminating Respondent due to her most recent suspension of her nursing license, and because she failed to notify the Facility that she was suspended between December 12, 2022, and January 17, 2023.

8. While Respondent's nursing license was suspended, she worked as a nurse on December 12, 17, 18, 21, 25, 29, and 30, 2022, and January 13 and 14, 2023.

9. Respondent confirmed in writing to the Department that she worked while she was suspended because she did not want to lose her job.

10. Respondent was convicted of Operating while Intoxicated 3<sup>rd</sup> on June 5, 2023, in Waukesha County case number 2023 CT 000416. Respondent was sentenced to 2 years' probation and required to comply with OWI treatment and conditions.

11. Respondent did not report the conviction to the department within 48 hours.

12. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

1. The Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07 and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. By the conduct described in the Findings of Fact, Respondent Practiced nursing without an active license within the meaning of Wis. Admin. Code § N 7.03(1)(d).

3. By the conduct described in the Findings of Fact, Respondent failed to notify the Board of a felony or misdemeanor in writing within 48 hours after the entry of the judgment of conviction within the meaning of Wis. Admin. Code § N 7.03(1)(h).

4. By the conduct described in the Findings of Fact, Respondent is unable to practice safely by reason of alcohol or other substance use within the meaning of Wis. Admin. Code § N 7.03(6)(e).

5. By the conduct described in the Findings of Fact, Respondent violated a law substantially related to the practice of nursing within the meaning of Wis. Admin. Code § N 7.03(2).

6. As a result of the above conduct, Respondent is subject to discipline pursuant to Wis. Stat. § 441.07(1g)(b), (c), and (d) and Wis. Admin. Code § N 7.03.

### ORDER

1. The attached Stipulation is accepted.
2. Respondent is REPRIMANDED.
3. Respondent's license to practice as a registered nurse (license no. 235225-30), and privilege to practice in Wisconsin pursuant to the Nurse Licensure Compact (Compact), are LIMITED as follows:
  - a. Within ninety (90) days of the date of this Order, Respondent shall at their own expense, successfully complete 6 hours of education on the topic of ethics. Each course attended in satisfaction of this Order must be pre-approved by the Board or its designee. Respondent shall be responsible for locating course(s) satisfactory to the Board and for obtaining the required approval of the course(s) from the Board or its designee. Respondent must take and pass any exam offered for the course(s).
  - b. Respondent shall submit proof of successful completion of the education in the form of verification from the institution providing the education to the Department Monitor at the address stated below. None of the education completed pursuant to this requirement may be used to satisfy any continuing education requirements that have been or may be instituted by the Board or Department, and also may not be used in future attempts to upgrade a credential in Wisconsin.
  - c. The Board or its designee may change the number of credit hours and/or education topics in response to a request from Respondent. The Board or its designee may consider the topic availability and/or hours of education when determining if a change to the ordered education should occur.
  - d. This limitation shall be removed from Respondent's license after satisfying the Board or its designee that Respondent has successfully completed all the ordered education.

4. Within ninety (90) days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$602.00. If costs are not paid within ninety (90) days from the date of this Order, interest shall accrue at the statutory rate of 12% per annum, pursuant to Wis. Stat. § 440.22(2).

5. Any requests, petitions, payments of costs (made payable to Department of Safety and Professional Services), and other information required by this Order shall be submitted to:

6. In the event Respondent violates any term of this Order, Respondent's license (no. 235225-30), or Respondent's right to renew her license, may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of the Order. The Board may, in addition and/or in the alternative refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.

7. This Order is effective on the date of its signing.

STIPULATION

**ORDER 00088 14**

Lisa O'Farrell, R.N., (Respondent), and the Division of Legal Services and Compliance, Department of Safety and Professional Services, stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.

2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Respondent;
- the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
- the right to testify on Respondent's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.

4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Board of Nursing (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division

of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.

7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.


