On October 18, 2023, the Wisconsin Medical Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete three (3) hours of education in "documentation and charting", three (3) hours of education in "acute assessment and stabilization of trauma patients", three (3) hours of education in "assessment and treatment of acutely encephalitogenic patients" within ninety (90) days and pay \$977.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

1. Respondent's license to practice medicine and surgery (#56627-20) is hereby returned to full, unrestricted status.
