On November 1, 2023, the Wisconsin Dentistry Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete three (3) hours of education on the topic of treatment planning, three (3) hours on performing root canals, and three (3) hours on record keeping within ninety (90) days and pay \$2,108.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent's license to practice dentistry (#3120-15) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
