The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Department of Safety and Professional Services (Department). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

- 1. Respondent Dayna J. Wolf, (Year of Birth 1971) is certified in the state of Wisconsin as a clinical substance abuse counselor, having credential number 16031-132, first issued on June 6, 2016, and current through February 28, 2025. Respondent is also certified as a substance abuse counselor, having credential number 15959-131, first issued on March 2, 2015. This credential expired on March 1, 2019, and has not been renewed. Pursuant to Wis. Stat. § 440.08(3), Respondent retains the right to apply for renewal of this credential until February 28, 2024.
- 2. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is in Little Chute, Wisconsin 54140.

- 3. At all times relevant, Respondent worked as a clinical substance abuse counselor at a social services agency located in Green Bay, Wisconsin. (Facility).
- 4. Between March 1, 2021, and June 25, 2021, Respondent provided AODA and counseling services to Patient BD in conjunction with Patient BD being prosecuted for OWI (4th) offense, a Felony, in Brown County Circuit Court, Case Number 2019CF0329. These services were provided as part of Respondent's employment with the Facility.
 - 5. Respondent resigned from the Facility effective July 22, 2021.
- 6. Patient BD's relationship with Respondent was professional while receiving AODA and Counseling services, but Respondent and Patient BD entered into a personal and intimate relationship in mid-September 2021.
- 7. As of the date of this Order, Respondent and Patient BD remain in a personal and intimate relationship.
- 8. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Department has jurisdiction to act in this matter pursuant to Wis. Stat. § 440.20 and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondent violated Wis. Admin. Code § SPS 164.01(2)(m) by engaging in inappropriate sexual contact, exposure, gratification, or other sexual behavior with or in the presence of a patient. An adult continues to be a patient for 2 years after the termination of professional services.
- 3. As a result of the above violations, Respondent is subject to discipline pursuant to Wis. Stat. § 440.20.

ORDER

- 1. The attached Stipulation is accepted.
- 2. The VOLUNTARY SURRENDER by Respondent of her certificate to practice as a clinical substance abuse counselor in the state of Wisconsin (license no. 16031-132), as well as her right to renew such license, is accepted.
- 3. In the event Respondent petitions the Department for reinstatement of her certificate to practice as a clinical substance abuse counselor in the state of Wisconsin or applies for another credential in the state of Wisconsin under Wis. Stat. chs. 440 through 480, Respondent shall pay the costs of this matter in the amount of \$5,050.00, before any petition or application for a credential will be considered by the applicable board or Department.

- 4. In the event Respondent petitions the Department for reinstatement as a clinical substance abuse counselor, the Department may enter an order denying such application without further notice or hearing. Whether to grant a license and whether to impose any limitations or restrictions on any license granted shall be in the sole discretion of the Department and such decision is not reviewable.
- 5. Any requests, petitions, payments of costs (made payable to Department of Safety and Professional Services), and other information required by this Order shall be submitted to:

Dayna J. Wolf, C.S.A.C. (Respondent) and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

- 1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.
- 2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:
 - the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
 - the right to confront and cross-examine the witnesses against Respondent;
 - the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
 - · the right to testify on Respondent's own behalf;
 - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
 - the right to petition for rehearing; and
 - all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
- 3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation. Respondent is represented by Attorney Jevon Jaconi.
- 4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Department of Safety and Professional Services (Department). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Department's Order, if adopted in the form as attached.

- 5. If the terms of this Stipulation are not acceptable to the Department, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Department, the parties agree not to contend that the Department has been prejudiced or biased in any manner by the consideration of this attempted resolution.
- 6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance may appear before the Department, without the presence of Respondent or Respondent's attorney, for purposes of speaking in support of this agreement and answering questions that the Department may have in connection with deliberations on the Stipulation.
- 7. Respondent is informed that should the Department adopt this Stipulation, the Department's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.
- 8. Respondent is further informed that should the Department adopt this Stipulation, the Department's Final Decision and Order will be reported as required by the National Practitioner Databank (NPDB) Guidebook and as otherwise required by any licensure compact or any other state or federal law.
- 9. The Division of Legal Services and Compliance joins Respondent in recommending that the Department adopt this Stipulation and issue the attached Final Decision and Order.
