On July 22, 2021, the Wisconsin Board of Nursing (Board) issued an Order Granting Limited License (Order) limiting Applicant's professional nursing license (#231584-30) with certain terms and conditions. Applicant may petition the Board for removal of the limitations after two (2) years of successful compliance with the Order including at least six hundred (600) hours of approved nursing practice each year.

On February 8, 2024, the Board considered Applicant's request for removal of the limitations and the return of her license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Applicant's request for the return of her professional nursing license (#231584-30) to full, unrestricted status is hereby DENIED.
2. This order is effective the date of its signing.
