On January 31, 2023, the Wisconsin Real Estate Appraisers Board issued a Final Decision and Order (Order) requiring Respondent to complete a total of twenty-six (26) hours of education in "Complex Properties: The Odd Side of Appraisal (7 Hours); National USPAP Course (15 hours); and Appraiser Self Protection: Documentation and Record Keeping (4 hours) within sixty (60) days. Respondent was also ordered to pay \$7,391 in costs of the proceeding within ninety (90) days, and pay \$1,000 in forfeiture within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs and forfeiture in full, the following is entered:

- 1. Respondent's certified residential appraiser credential (#1756-9) is hereby returned to full, unrestricted status.
 - 2. All limitations and encumbrances upon Respondent's credential are removed.
 - 3. This order is effective the date of its signing.
