On August 1, 2023, the Wisconsin Real Estate Appraisers Board issued a Final Decision and Order (Order) requiring Respondent to complete a total of twenty-nine (29) hours of education in the National USPAP course (15 hours), Residential Appraisal Review and USPAP Compliance (7 Hours), and Residential Property Inspection for Appraisers (7 Hours) within sixty (60) days and pay \$840 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent's certified residential appraiser credential (#1657-9) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
