On August 29, 2023, the Wisconsin Massage Therapy and Bodywork Therapy Affiliated Credentialing Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice massage therapy and bodywork therapy for an indefinite period. Respondent is required to complete six (6) hours of education on recordkeeping, six (6) hours on the topic of ethics, and two (2) hours on the topic of informed consent. Respondent shall pay \$1,300.00 in costs of the proceeding within ninety (90) days. Respondent shall provide proof of compliance with the insurance requirements found in Wis. Stat. 460.05(1)(g).

Respondent has submitted a request for removal of the limitations and the return of her license to full, unrestricted status. Based upon the information of record, the following is entered:

ORDER

1. Respondent's request for the return of her license to practice as a massage therapist or bodywork therapist (#12966-146) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Respondent's credential are hereby removed.
3. This order is effective the date of its signing.
