On November 1, 2023, the Wisconsin Dentistry Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete fourteen (14) hours of education on the topic of opioid prescribing and charting within four (4) months and pay \$750.00 in costs of the proceeding within ninety (90) days.

1. Respondent's license to practice dentistry (#4715-15) is hereby returned to full, unrestricted status.
