On December 14, 2023, the Wisconsin Board of Nursing issued a Final Decision and Order (Order) requiring Respondent to complete four (4) hours of education in "professional accountability in nursing" within ninety (90) days and pay \$435 in costs of the proceeding within ninety (90) days.
