___ (6) I understand that I am governed by the above mentioned and other policies, and in the event of a conflict between documents, The Woolf Policy of Quality Assurance overrides the Privacy Policy and Terms, which override the descriptions of the module(s)/course(s)/degree offering(s) I am choosing to pursue on the Woolf platform, which overrides the Woolf Academic Handbook, which overrides a College handbook, should one exist.

___ (7) I have carefully reviewed the red flag procedure located both in the Policy of Quality Assurance and the Woolf Academic Handbook. I understand if, when, and how to escalate any issues or complaints that may arise during my time enrolled or any disciplinary actions I may face by failing to adhere to Woolf's Community and Academic Standards. I understand that the red flag procedure also governs areas of dispute resolution, but does not preclude the student from seeking other legal remedies.

___ (8) By submitting my Agreement, I understand and acknowledge that in the event a member college has provided an agreement which is in direct contradiction or cannot be rectified against a term or provision of the Agreement that I will be bound and subjected to the requirements of this agreement with the relevant term or provision severed from the member college agreement.

___ (9) I understand and agree that any dispute or claim arising out of, or in connection with this agreement, breach thereof, or any unresolved disputes related to instruction provided to me during the course of the Program, shall be settled by binding arbitration in the City and County of San Francisco, California under the Rules of Arbitration of the International Chamber of Commerce by three arbitrators appointed in accordance with said rules. Judgment on the award rendered by the arbitrators may be entered in any court having jurisdiction thereof.

Notwithstanding the foregoing, either party may apply to any court of competent jurisdiction for injunctive relief without breach of this action.

___ (10) I understand that if any term or other provision of this agreement is determined by a court of competent jurisdiction to be invalid, illegal or incapable of being enforced by rule of law or public policy, such term or provision will be modified by such court to the minimum extent necessary to make it valid and enforceable. If such modification is not possible, the relevant

term or provision shall be severed, and the remaining terms of this agreement will continue to be valid and enforceable to the fullest extent permitted by law.

___ (3) I understand that concerns or complaints against the College should utilize the red flag procedure as outlined in the Woolf Policy of Quality Assurance.

___ (4) I understand that the College and the staff members of the College will be responsible for providing any and all instruction for the program that I have signed up for.

___ (5) I understand that the College is solely responsible for all admission criteria and determines if I am admitted into the program that I am applying to. Information about admission criteria and process are outlined in the Policy of Quality Assurance.

___ (6) I acknowledge that I have reviewed any Academic Handbook that the College has provided, if one should exist.

___ (7) I understand that the College may or may not offer employment or career services. If it does, I understand that the College is responsible for any outcome related areas such as employment or career services, and that any guarantees or marketing claims surrounding the outcome or employability associated with the program are at the discretion of the College and not Woolf or its other Collegiate partners. Should I believe misrepresentation has occurred I agree to highlight concerns through the red flag procedure.

(8) I understand that, notwithstanding anything contained in this agreement, or elsewhere, I may potentially not be entitled to a refund, if I raise a refund request for tuition or course fees paid to the college for a program, 3 business days after receipt of notice of acceptance.

___ (9) I understand that the the Woolf, the College and the program/courses offered by the College are not accredited/approved by the Indian University Grants Commission, or any other Indian regulatory authority and that the Association of Indian Universities may not accord equivalence to foreign degrees that have been obtained for studies undertaken through online/virtual modes.

Program Enrollment Agreement

You hereby agree to pay any tuition and fees associated with the program(s)/course(s) in which you are enrolling and Woolf, or its member college, agrees to provide instruction in the program(s)/course(s) listed. You acknowledge that some courses may require the purchase of materials, or incur other costs for their successful completion, that are outside of the tuition and fees associated with the program(s) or course(s). These additional costs are publicly available and outlined on Woolf's website.

You, Woolf, and Woolf's member colleges agree to abide by the duties and default clauses listed below. Additionally, Woolf and its member college, like you, agree to abide by the conditions, requirements and restrictions outlined within this agreement.

___(4) In order to complete the **Program** I am required to complete the total **Program Hours** listed above, at a total cost equal to the **Program Cost** listed above through a proprietary online platform.

___(5) I understand and agree that should I seek an additional enrollment in a program(s) not covered within this agreement, I will be required to sign an additional agreement outlining

coverage for those offerings. These additional offerings will be at the stated price of that agreement, and I will agree to pay any tuition and fees associated with the additional offerings.

___ (6) The **Program** is an academic program provided by Woolf and is administered and taught primarily online in English, unless otherwise specified on the degree profile available on the website, by the **College**, a constituent member of Woolf.

___(7) The **Program** confers an academic degree or academic credits and does not itself constitute a professional credential/license.

___ (8) I understand that the **College** is solely responsible for all admission criteria and determines whether I am admitted into the program to which I am applying. Information about admission criteria and process are outlined in the Policy of Quality Assurance.

___(9) I have reviewed and understand the entry level requirements, structure of the program, intended learning outcomes, teaching, learning and assessment procedures for the **Program** located at <https://woolf.university/degrees>.

___ (10) Woolf's administered programs are accredited under **License Authority**. I understand that each country, state, province and/or region has its own standards, policies and requirements which may be beyond the scope of the **Program** to support. Additionally, I understand that the **Program** may not be authorized or recognized in all jurisdictions and I undertake this program for the sole purpose of academic fulfillment and disclaim all warranties associated with jurisdictional oversight or restrictions.

___(11) I understand that Woolf does not, at this time, provide any employment/career services, nor does it guarantee any employment outcomes associated with the **Program**. Woolf is not responsible for the employment services provided by the **College**, or for their claimed employment outcomes. Should I believe misrepresentation has occurred I agree to highlight concerns through the red flag procedure as outlined within the Academic Handbook and the Policy of Quality Assurance.

___ (12) I acknowledge that if I have departed the **Program**, voluntarily or involuntarily, that I may or may not be able to return to it, either to finish or add to my existing courses/degree, and that returning is solely at the discretion of the member college which I attended. I understand that I will be responsible for the associated program costs which may be incurred.

___ (13) I acknowledge that I may have the option to use the courses and their credits that I have taken in this **Program**, and count them towards a different degree or alternative outcome. This use of credits may not be available in all **Programs** and is at the discretion of Woolf and the **College**. I understand that should this possibility be available to me I will be informed of my options. I also understand and acknowledge that the terms of this agreement will apply *mutatis mutandis* to that degree or alternative outcome.

___ (14) I understand that the **Program** may require me to purchase additional learning materials or incur other additional marginal costs including but not limited to travel, software applications, or computer hardware - and that such costs are not included in this Enrollment Agreement and are at the discretion of member colleges. The cost of additional materials are published on the Woolf website for each individual module.

___ (15) I understand that during my participation in the **Program**, I will access my courses, assignments, and interact with staff and other students through the Woolf website. Once enrolled, I will receive access to the portion of the site which will allow me to enroll in specific cohorts and to gain access to general institutional information, **Program** information, the asynchronous materials that are part of my **Program**, and other information pertinent to the **Program**.

___ (16) I understand that completing the **Program**, particularly the synchronous portion, may require the use of third party software which may be integrated through Woolf's or the **College's** site, but have their own Terms and Conditions which I have read and agreed to.

___ (17) While taking exams or otherwise participating in the **Program**, I may be required to submit information to verify my identity, including biometric data, or record my screen to detect potential academic misconduct. Failure to adhere to these requirements, or any action deemed to be academic misconduct, may result in disciplinary action up to and including dismissal from the **Program** without a refund.

___ (18) I have reviewed and been fully informed of Woolf's Tuition Cancellation and Refund Policy, which is located in the Woolf Academic Handbook. [[LINK](#)]

___ (19) I understand and have been informed that upon receipt of this contract that I have up to three business days to cancel my enrollment. If I fail to cancel my enrollment within the three business day period, or have in some way falsely represented myself in any written or oral

representation to Woolf, I may not be eligible for a full refund. Students who successfully utilize the cancellation policy will have their refund made within 10 business days.

___ (20) I understand and have been informed that if I withdraw or am dismissed from the Program after the above mentioned three business day period, but before completing 60% of the potential units of instruction in the current enrollment period, I may be entitled for evaluation for a pro rata refund as calculated by the Woolf Tuition Cancellation and Refund Policy, which is located in the Woolf Academic Handbook.

___(21) I acknowledge that this *Program Enrollment Agreement* adds to the previously signed sections and agreements, specifically the *Woolf Agreement* and *College Agreement*, and I agree to abide by all of the terms and conditions outlined in those previous agreements.
